My name is Dave Kingery and I am submitting public comment on behalf of The Carlyle Group and 1548 Maple, LLC, owner of the residential development project located at 1548 Maple St.

When we decided to invest in Redwood City, one of the reasons for investing was the inner harbor vision which included a large park in the community. We felt this was a huge amenity not just for the future project residents, but also for the entire Redwood City community. The project includes tremendous community benefits including a creekside park open to the public and maintained at no cost to the City. We understood that the city wanted to extend Blomquist and that there would be a land swap with the county where the county would move to 1402 Maple. We were okay with either the outcome where the County moved to 1402 Maple or stayed in its current location.

We understand that the City is now considering taking approximately half the large parcel across the street envisioned for a park as part of the inner harbor planning process as the new land to be swapped with the County rather than the 1402 Maple site. We believe this option significantly reduces the size and potential of the park as an amenity for the neighborhood and community at large. We ask that you remove any option for the land swap that entails breaking up the large park parcel which would diminish forever the potential of the inner harbor as a recreational area and community gathering spot in Redwood City. I believe most residents in Redwood City would be in agreement with me.
