The following declaration of change of membership of the Design Board established by the hereinafter referred to Declaration of Restrictions, Conditions, Covenants and Charges for Residential Development known as DOLPHIN SUBDIVISION NO. 1, is made this 15TH day of July, 1985, by REDWOOD SHORES, INC., a California corporation, formerly LESLIE PROPERTIES, INC., a California corporation, hereinafter referred to as "Declarant".

WITNESSETH:

WHEREAS, Declarant has heretofore established a Declaration of Restriction, Conditions, Covenants and Charges for Residential Development known as DOLPHIN SUBDIVISION NO. 1 affecting the lands described in Exhibit "A" hereto, and has caused the same to be recorded in the Office of the Recorder of San Mateo County, California on the 7th day of March, 1969, in Volume 5608, Page 151 Recorder's Serial No. 18352AC; and

WHEREAS, said Declaration of Restrictions, Conditions, Covenants and Charges for Residential Development known as DOLPHIN SUBDIVISION NO. 1 provides for and creates a Design Board of three (3) individuals, and provides for the replacement of any members of the Design Board at any time, with or without cause; and

WHEREAS, Declarant has determined to change the membership of said Board;

NOW, THEREFORE, Declarant hereby declares that from and after the date hereof the membership of the Design Board referred to in the
