RESOLUTION VACATING NON ACCESS RESTRICTION OVER A PORTION OF A PUBLIC STREET (TWIN DOLPHIN DRIVE) IN THE CITY OF REDWOOD CITY IN ACCORDANCE WITH PART 3 OF DIVISION 9, STREETS AND HIGHWAYS CODE OF THE STATE OF CALIFORNIA

WHEREAS, pursuant to the provisions of Part 3 (commencing at §8300) of Division 9 of the Streets and Highways Code of the State of California, the Council of the City of Redwood City by its Resolution No. 9764, adopted January 7, 1985, declared its intention to vacate the hereinafter described non access restriction along a portion of Twin Dolphin Drive; and

WHEREAS, pursuant to said provisions of the Streets and Highways Code, notice of intention to vacate the abovementioned non access restriction has been published and posted; and

WHEREAS, a public hearing has been held and evidence taken;

NOW, THEREFORE:

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF REDWOOD CITY, AS FOLLOWS:

1. The Council of the City of Redwood City finds that the hereinafter described non access restriction is unnecessary for present or prospective public purposes and hereby orders said non access restriction vacated.

2. The non access restriction to be vacated was established by and designated on that certain map entitled "Shores Center Unit No. 1" as recorded in Volume 106 of Maps,

BEGINNING at Monument No. 15 on Twin Dolphin Drive as shown on that certain Parcel Map entitled "Shores Center Unit No. 1" filed for record in the office of the County Recorder of San Mateo County, State of California in Volume 106 of Parcel Maps at pages 3-5; thence from said Point of Beginning South 44°32'43" East, 21.34 feet; thence North 45°27'17" East, 45.00 feet to the TRUE POINT OF BEGINNING of the non-access line to be described hereby; thence from said TRUE POINT OF BEGINNING along the Westerly boundary of Lot 6 and the Easterly boundary of Twin Dolphin Drive, North 44°32'43" West, 21.34 feet; thence along the arc of a tangent curve to the left with a radius of 1,045.00 feet, through a central angle of 9°44'04", for an arc length of 177.55 feet to the end of the non-access line. Thence from last said point, leaving the boundary described above, radial to the last said curve South 35°43'13" West, 45.00 feet; thence along the arc of a non-tangent curve to the right with a radius of 1,000.00 feet, and to which beginning a radial line bears South 35°43'13" West, through a central angle of 9°44'04", for an arc length of 169.90 feet to the Point of Beginning described above.

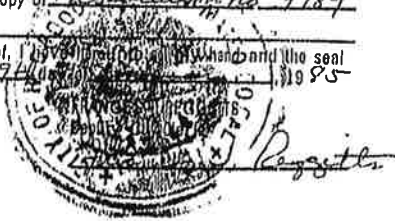
