RESOLUTION APPROVING AND AUTHORIZING EXECUTION OF REVOCABLE ENCROACHMENT PERMIT RELATING TO USE FOR BUS STOP PURPOSES OF CERTAIN CITY-OWNED REAL PROPERTY

WHEREAS, Redwood Shores Homeowners Association, has requested permission to use for bus stop purposes said real property described in "Exhibit A" and shown in red on "Exhibit B" of that certain revocable permit attached hereto; and

WHEREAS, it is the intention and desire of this Council to grant a revocable encroachment permit permitting such use, subject to certain designated terms and conditions;

NOW, THEREFORE;

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF REDWOOD CITY, AS FOLLOWS:

1. That the City Manager is hereby authorized to execute a revocable encroachment permit to Redwood Shores Homeowners Association for use for bus stop purposes of that certain City-owned real property, more particularly described in "Exhibit A" and shown in red on "Exhibit B" of that certain revocable encroachment permit attached hereto and by this reference incorporated herein, which permit shall not be effective until such time as Redwood Shores Homeowners Association executes an acceptance of its terms and conditions.

2. That the permit granted shall be in the form of that certain permit entitled "Grant of Revocable Encroachment Permit - Bridge Parkway and Bowsprit Drive" (form dated 2/22/78), attached hereto and incorporated herein as if set out at length herein.

LEGAL DESCRIPTION

BUS STOP - REDWOOD SHORES HOMEOWNERS ASSOCIATION

All that certain real property situate in the City of Redwood City, County of San Mateo, State of California, described as follows:

A portion of Bridge Parkway right-of-way as shown on that certain map entitled "Redwood Shores Subdivision No. 1," filed in the Office of the County Recorder of San Mateo County on May 27, 1968, in Book 67 of Maps at Pages 42, 43, and 44, more particularly described as follows:

BEGINNING at Mon. No. 1 as shown on said map; THENCE southwesterly along the prolongation of the center line of Bowsprit Drive as shown on said map, South 43° 19' 38" West a distance of 48 feet to a point on the southerly boundary line of said subdivision, said southerly subdivision boundary line also being the southerly right-of-way line of Bridge Parkway as shown on said map; THENCE southeasterly along said southerly boundary line, South 46° 40' 22" East a distance of 90.00 feet to a point on said southerly boundary line, said point also being the TRUE POINT OF BEGINNING; THENCE continuing southeasterly along said southerly boundary line, South 46° 40' 22" East a distance of 12.00 feet to a point on said southerly boundary line; THENCE North 43° 19' 38" East a distance of 13.5 feet; THENCE North 46° 40' 22" West a distance of 12.00 feet; THENCE South 43° 19' 38" West a distance of 13.5 feet to the TRUE POINT OF BEGINNING.
