

RESOLUTION NO. 16168

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDWOOD CITY APPROVING AN APPROPRIATION AMENDMENT TO THE FISCAL YEAR 2023-2024 BUDGET TRANSFERRING UNENCUMBERED FUNDS FROM OTHER CAPITAL PROJECTS IN THE AMOUNT OF \$902,254 FOR PROFESSIONAL SERVICES COSTS

WHEREAS, during the course of a fiscal year, the City Council may take actions that change or modify the City’s existing and approved budgets; and

WHEREAS, appropriations need to be established in order for staff to authorize Amendment No. 2 to Agreement with Gilbane Building Company and Amendment No. 3 to Agreement with ELS Architecture and Urban Design for professional services related to the Veterans Memorial Building/Senior Center-YMCA Project; and




